IV. UNFINISHED BUSINESS

1. Resolution 2020-02, Adopting Bylaws for PSURA

The Authority discussed the bylaws which can be simple and provide for the governance and structure of the new Commission to clarify or expand upon the statutory requirements.

Commissioner Schulte moved to approve Resolution 2020-02, adopting Bylaws for the Pagosa Springs Urban Renewal Authority, Commissioner deGraaf seconded.

V. NEW BUSINESS

1. Resolution 2020-03, Opposition to Charter Amendment Pertaining to TIF Funding for Projects

The Town attorney drafted resolution 2020-03 stating opposition to the proposed charter amendment set for election July 14, 2020. Commissioner concerns include potential lawsuits from developers, which would be a lengthy and expensive process, possibly wasting taxpayer money. Attorney Buchner said the resolution consolidates the opinions of the commission. Commissioner Pierce said she is not in favor of the sentence in the resolution that urges citizens to vote against the ballot. Commissioner Ford said there are differences in the case of Wheat Ridge and doesn't feel they are identical as stated in the resolution. He does not support the URA passing the resolution, he said the Town Council is the one that should pass an opposing resolution if they deem appropriate. Commissioner DeGuise said he believes if the question is passed by the voters a lawsuit against the town will likely follow. Commissioner Schulte said the Wheat Ridge case is nearly identical and he would deferred to the Town attorney's recommendations. Commissioner deGraaf said he agrees with Commissioner Ford that the URA does not need to come out as a board in opposition of the ballot question. Board Chair Volger said he wanted the resolution to provide the facts for the community. He said it could be reworded to provide information and not a resolution opposing the proposed amendment. Commissioner Woodruff said a

Commissioner deGraaf moved to deny Resolution 2020-03, opposition to charter amendment pertaining to TIF funding for projects, Commissioner Pierce seconded, motion does not pass with 5 ayes and 5 nays.

RESOLUTION NO. 2020-03

A RESOLUTION ADOPTING A GUIDING VISION AND DEVELOPMENT PRINICIPLES FOR THE PAGOSA SPRINGS URBAN RENEWAL AUTHORITY

WHEREAS, the legislature of the State of Colorado declares in C.R.S. § 31-25-102 (1) that the prevention and elimination of slums and blight is a matter of public policy and statewide concern; and

WHEREAS, pursuant to authority granted it by C.R.S. 31-25-102, on November 5, 2019, the Pagosa Springs Town Council adopted Resolution 2019-18 that made Findings of the existence of blight within the Town boundaries and established the Pagosa Springs Urban Renewal Authority (PSURA); and

WHEREAS, an 11 member Board of Commissioners for the PSURA was established and first convened on April 15, 2020; and

WHEREAS, the PSURA Board of Commissioners agreed it was desirable for the Authority to elect officers, adopt bylaws, and create a guiding vision for the newly created Authority; and

WHEREAS, upon further examination and discussion by the PSURA Board of Commissioners, it was further agreed that the guiding vision and development goals of the PSURA should be consistent with the recently adopted update to the Town of Pagosa Springs General Plan, known as *Pagosa Springs Forward* (April 2018);

NOW THEREFORE BE IT RESOLVED THE PAGOSA SPRINGS URBAN RENEWAL AUTHORITY FINDS AND DECLARES THE GUIDING VISION AND DEVELOPMENT PRINCIPLES SHALL BE AS FOLLOWS AND THE AUTHORITY SHALL USE ITS BEST EFFORTS AND RESOURCES TO ACCOMPLISH THE SAME:

Guiding Vision

"Pagosa Springs desires to promote and sustain an authentic Colorado mountain experience in a culturally rich, economically diverse town set in a vibrant, healthy environment. The very existence of the Pagosa Springs Urban Renewal Authority and its efforts should be in support of these goals."
